IACP Subsidised Training for Members in "Child Protection and the Counsellor / Psychotherapist" 2015

Over the coming months, the IACP will be providing subsidised training to IACP Members in "Child Protection and the Counsellor / Psychotherapist" at different venues across the country.

Mandatory reporting of Child Sexual Abuse is being introduced by the Government in Ireland.

This course aims to:

- Provide clear information to Counsellors / Psychotherapists working with Adult Survivors of Child Sexual Abuse regarding their legal obligations to report retrospective allegations
- Explore strategies to manage the impact on the Therapeutic Relationship

The course is participative, experiential, includes presentations, small group work and role plays.

Extensive hand-outs will be provided.

The training is being presented by the organisation One in Four. (Please see Course Outline and more information on One in Four below).

This is a **One Day Course**, which is <u>repeated</u> in each venue around the country.

- 1. The purpose of the Supervision Sub-Committee is to assess applications for Supervisor Accreditation and to recommend criteria for Supervisor Accreditation or any other issues pertaining to Supervision.
- 2. With the exception of one member (point 3) all members of the Supervision Committee must be Accredited Supervisors of IACP.
- 3. A committee place for 1 Accredited member who is not an Accredited Supervisor (to serve one 3 year term only)
- 4. A committee place for up to 2 retired Supervisor members (to serve one 3 year term only)
- 5. For all other Supervision Committee members, membership shall be for a minimum of 2 years and a maximum of 2 consecutive terms (6yrs)

CIPC is the provision of short term counselling in primary care settings to medical card holders aged 18 years and over by professionally qualified counsellors, psychotherapists and psychologists under the governance of the HSE Directors of Counselling.
